## FROM THE PRESIDENT'S PEN

Wow! There are lots of exciting things going on and your Richardson League of Women Voters is active!

Early voting in person for the Republican and Democratic Party Primary Elections is in full swing. Early voting continues until Friday, February 28, 2014. Election day is Tuesday, March 4, 2014. See pages 4-7 for more information on the primary.

**Low Voter Turn-out:** The Dallas League of Women Voters conducted a survey in 2005 on voting patterns among Texas women. They found that 33.4% of Texas women don't vote **because they are not informed of the issues**. The 2013 Texas Civic Health Index Report by the Annette Strauss Institute for Civic Life at UT Austin **found that Texas ranks 44<sup>th</sup> in the number of people who discuss politics a few times a week or more.**



**Did you know** that there are propositions at the bottom of the March 4<sup>th</sup> ballots? (See page 7) These propositions are non-binding, meaning that they will not become law based on this election. However, it is an opportunity for you to make your voice heard in the party.

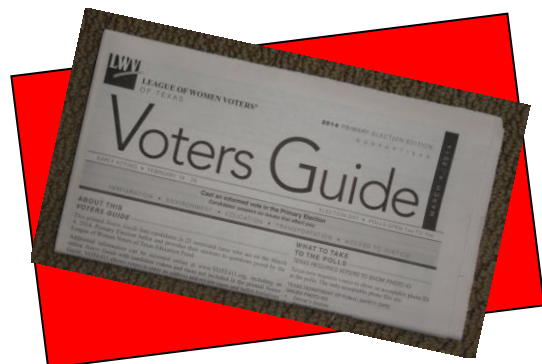

## VOTERS GUIDE for March 4, 2014 Primary Election

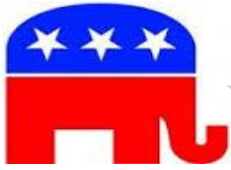

# Texas Primary

## March 4, 2014



**What is a Primary Election?** The Republican and Democratic parties in Texas will each hold a primary election on Tuesday, March 4, 2014. The chosen candidate will represent the party in the upcoming general election, to be held on Tuesday, November 4, 2014.

Minor political parties (parties whose gubernatorial candidate received less than 20% of the vote in the previous general election) do not hold primary elections. Instead, minor political parties select their candidates at a convention. Independent and write-in candidates can get on the general election ballot by collecting signatures on a nominating petition.

**May I vote in both primaries (Republican and Democratic)?** No. You may vote in either primary, but not in both primary elections. Once you've voted in one party's primary, you may not vote in the other party's run-off, if there is one.

**Why would there be a runoff election?** In a primary election, a runoff is held when no candidate for a particular race gets more than 50% (*50% plus one vote*) of the votes cast. When there is no clear winner, there is a runoff between the top 2 vote-getters.

If a runoff election is necessary, it will be held May 27, 2014.

**If I vote in the primary election, do I have to vote for the same party in the general election in November?** No. Who you vote for in the March primaries has no bearing on who you may vote for in November. You are free to vote for either party, or a mixture of all parties, in the November election, whether you voted in the primary election or not.

**Can anyone tell who I vote for in the primary?** No. When you vote in the primary election, your voter registration card will be stamped to show that you voted. There is no record to indicate for whom you voted.

## Election Day voting

**Where and when can I vote on election day, March 4, 2014?**

**Polls are open 7am – 7pm.**

### Dallas County

On election day in Dallas County, you must vote in your precinct. (*Your precinct number is on your voter registration card, next to your year of birth.*)

Polling places for the Republican Primary Election may be in a different place than for the Democratic Primary Election for the same precinct. For example, if you live in Precinct 2509, you will vote at Richardson East Church of Christ for the Republican Primary or Yale Elementary for the Democratic Primary.




## Statements on the March 4, 2014 Ballot

The following statements will be on your ballot at the March 4, 2014, Primary Election. The statements presented by the Republican Party will not be the same as those presented by the Democratic Party. The Republican Party ballot poses 6 statements, while the Democratic Party ballot poses 4 statements. Depending upon whether you vote in Dallas or Collin County, the response to each question will be to vote:

The election results on these statements are not binding. These are statements being posed by the political parties.

<b>Republican Party</b>	<b>Democratic Party</b>
<p><b>Religious Freedom</b> Texans should be free to express their religious beliefs, including prayer in public places.</p>	<p><b>On Immigration Reform</b> The United States Congress must pass immigration reform; including an earned path to citizenship for those individuals contributing to the economy and the dependents of those individuals.</p>
<p><b>Second Amendment</b> Texas should support Second Amendment liberties by expanding locations where concealed handgun license-holders may legally carry.</p>	<p><b>A Living Wage For All Texans</b> Congress should pass legislation raising the federal minimum wage to at least 110% of the federal poverty level for a family of four without exception.</p>
<p><b>Franchise Tax</b> Texas should abolish the state franchise tax, also known as the margins tax, to encourage business growth.</p>	<p><b>Medicaid Expansion</b> The Governor and the Texas Legislature should accept federal funds; as provided in the Patient Protection &amp; Affordable Care Act of 2010; for the expansion of Medicaid to provide coverage to millions of uninsured and underinsured Texans.</p>
<p><b>Welfare Reform</b> Texas recipients of taxpayer-funded public assistance should be subject to random drug testing as a condition of receiving benefits.</p>	<p><b>On Non-Discrimination Legislation</b> The Congress and the Texas Legislature should adopt legislation that expands protections against discriminations in employment; housing; and public accommodations based upon sexual orientation and gender identity.</p>
<p><b>No Lawmaker Exceptions</b> All elected officials and their staff should be subject to the same laws, rules, regulations, and ordinances as their constituents.</p>	
<p><b>Obamacare</b> The Affordable Care Act, also known as "Obamacare," should be repealed.</p>
