ANNUAL MEETING HIGHLIGHTS

May 4, 2016 Casa Milagro Restaurant

Members present at the League of Women Voters of Richardson Annual Meeting:

- voted to retain all current local Program positions.
- voted not to undertake any new studies. The recommendation followed discussion of the
 possibility of studying various environmental issues, such as clean air, water quality, and the
 possible need for a tree ordinance. It was decided that there were state and national positions
 adequate for local advocacy.
- recommended continuing to advocate for CHIP and advocating on water quality, especially if old pipes or lead contamination prove to be problems in Richardson.
- adopted the 2016-17 budget.
- elected new officers and directors to the board.
- thanked outgoing President Brenda Boston for her service this past year;
- bid a fond, though reluctant, farewell to longtime member Jane Daboub, who will be joining LWV-Dallas.
- in keeping with tradition, expressed their hopes for activities the League might continue or undertake during the coming year, in the segment entitled "I Wish the League Would...."

2015-2016 Year in Review

The League of Women Voters of Richardson put in a full year in service to its community – the citizens of the City of Richardson and the Richardson ISD.

Voter Service

- We hosted a public informational program and published a pro/con Voters Guide on the 83 proposed amendments to the City Charter.
- In each of the four high school attendance areas, we manned voter registration tables at RISD informational meetings concerning the bond election.
- We published a pro/con Voters Guide on the RISD bond proposal.
- We planned a candidate forum for the RISD Board of Trustees election, but it was cancelled, according to LWV policy, due to the refusal of a candidate to participate.
- We published both written and online Voters Guides for the RISD Board of Trustees election.
- We published our online Voters Guides on LWV's <u>www.VOTE411.com</u> website.
- We worked with other local Leagues to produce the region's portion of the LWV Voters Guide for the Primary Elections.

Program of Education and Advocacy

- Members attended a public meeting sponsored by LWV-Collin County on Payday and Auto Loans in Texas, the topic of a statewide LWV study this year. We then held a lively consensus meeting at which our members provided grassroots input that will help form the basis for a state position on the issue.
- As part of our ongoing Periodic Program Review, members met to participate in an in-depth review our local positions on Child Care and Public Health Care Services.
- We hosted a public informational program on "Emergencies in the Richardson Area," focusing
 on the government's role in emergency response, personal preparedness, and ways to
 volunteer to help your community during disasters and emergencies.

Community

- In the name of the League, a member generously sponsored the Government table at the Friends of the Library book sale.
- LWV-R members participated with volunteers from partner organizations in registration drives for CHIP (the Children's Health Insurance Program).


Communications

- We updated and distributed our local Guide to Elected Officials.
- We responded to numerous phone calls and emails from the public, especially regarding voter registration and voting mechanics.
- Our monthly VOTER newsletter was emailed to members and contributors, and was available to the public on our website.
- We tweeted important information about elections and LWV events.

Website (www.lwvrichardson.org):

- Our website was maintained with important election information for the:
 - November, 2015 Joint Election;
 - March 1, 2016 Primary Elections;
 - May 7 Joint Election; and
 - May 24 Primary Runoff Elections.
- Election information included:
 - links to dates/times for early voting and election day voting for Richardson residents in both Dallas and Collin Counties;
 - o links to sample ballots;
 - a link to <u>www.VOTE411.org</u> for LWV Voters Guides and information on the locations of printed LWV Voters Guides;
 - current information on the mechanics of voting, including information on photo identification; and
 - a page of Frequently Asked Questions about Primary Elections.
- Videos of candidate forums and public programs were embedded on the website for those who
 were unable to attend in person.
- Although usage tends to peak near elections, the public's use of LWV-R's website continues to increase. The chart below shows average monthly Requests for Pages for each of the 10 fiscal years (June May) during which LWV-R's website has been active. During the 2015-16 year, the average number of monthly Requests for Pages was 7724.

Richardson ISD Bond Election

Richardson ISD voters approved the \$437 million bond with 66.98% of the 9,509 votes cast.

The bond contains

- \$215.7 million for maintenance.
- \$107.27 million for capacity/construction, and
- \$114.1 million for enrichments.

May 24, 2016 Primary Runoff Elections Statistics

On May 24, 2016, the Texas Republican Party and the Texas Democratic Party had a runoff election for their Primary Elections (which were held on Super Tuesday, March 1, 2016).



Dallas County

In Dallas County

- the Republican Party Runoff Election was for Railroad Commissioner; Judge, Court of Criminal Appeals, Place 2; Judge, Court of Criminal Appeals, Place 5; and Sheriff.
- the Democratic Party Runoff Election was for Railroad Commissioner, Criminal District Judge, Court No. 2; County Tax Assessor-Collector, and Constable, Precinct No. 1.

Dallas County has a population of 2.48 million people. There are 1,233,701 registered voters. That means that 49.75% of people in Dallas County are registered to vote.

Of those registered voters:

- 0.08% cast ballots in the Republican Party Primary Runoff Election.
- 2.34% cast ballots in the Democratic Party Primary Runoff Election for Constable, Precinct 1 (160 precincts)
- 1.25% cast ballots in the Democratic Party Primary Runoff Election for the other races. (797 precincts)

Collin County

In Collin County

- the Republican Party Runoff Election was for Railroad Commissioner; Criminal Appeals Judge, Place 2; Criminal Appeals Judge, Place 5; District 416 Judge; Justice of the Peace, Precinct 3, Place 1
- the Democratic Party Runoff Election was for Railroad Commissioner.

Collin County has a population of 854,778 people. There are 512,696 registered voters. That means that 60% of people in Collin County are registered to vote.

Of those registered voters:

• 2.39% cast ballots in either the Republican Party or Democratic Party Runoff Election

Important Women in History





Carrie Clinton Lane was born in Ripon, Wisconsin on January 9, 1859. She was the second of three children of Lucius and Maria Lane. Her family moved to rural Charles City Iowa when she was seven years old. She graduated from high school there in 1877 and in 1880 graduated from the Iowa Agricultural College and Model Farm in Ames (now Iowa State University). She graduated at the top of her class, having worked her way through school by washing dishes, working in the school library, and teaching. She was the only woman in her graduating class. After college, she returned to Charles City to work as a law clerk and in nearby Mason City, as a school teacher and a principal. In 1883, she became one of the first women in the nation appointed superintendent of schools.

In February 1885, Carrie married Leo Chapman, editor and publisher of the Mason City Republican. Mr. Chapman died of typhoid fever the following year in San Francisco, California, where he had gone to seek new employment. Arriving a few days after her husband's death, the young widow decided to remain in San Francisco where she was employed by a newspaper during part of that time. In 1887, Carrie returned to Charles City and joined the Iowa Woman Suffrage Association for whom she worked as a professional writer and lecturer. After a short period of time, she became the group's recording secretary. From 1890 to 1892, she served as the Iowa association's state organizer.

At the time of Carrie Chapman's rise to her state organization's highest office, she married George Catt in June 1890. Mr. Catt was a fellow lowa Ag. College alum whom she had met during her stay in San Francisco, and who encouraged her suffrage activity. As Mrs. Catt established her reputation as a leading suffragist, she was asked by Susan B. Anthony, president of the National American Woman Suffrage Association (NAWSA), to address Congress on the proposed suffrage amendment. In 1900, she succeeded Anthony as the NAWSA president. From then on, her time was primarily spent in speechmaking, planning campaigns, organizing women, and gaining political experience.

In 1902, Catt helped organize the International Women Suffrage Alliance (IWSA), which eventually incorporated sympathetic associations in 32 nations. In 1904, she resigned her NAWSA presidency in order to care for her ailing husband. His death in October 1905, followed by the deaths of Susan B. Anthony (February 1906), Catt's younger brother William (September 1907) and her mother (December 1907) left Catt grief-stricken. At the encouragement of many, she spent much of the next eight years traveling worldwide and promoting equal-suffrage rights.

Catt returned to the States in 1915 to resume leadership of the NAWSA and unveiled her "Winning Plan" to campaign simultaneously for suffrage on both state and federal levels, and to compromise for partial suffrage in the states resisting change. Under her dynamic leadership, backing was won in the U.S. House and Senate and the states' support for the amendment's ratification. On August 26, 1920 the Nineteenth Amendment officially became part of the U.S. Constitution and all women were granted the right to vote.

After this victory, Catt stepped down from her NAWSA presidency and continued her work for equal suffrage, promoting education of the newly-franchised by founding the new League of Women Voters and serving as its honorary president until her death in on March 9, 1947 in New Rochelle, New York.
