## Annual Meeting May 13, 2015

Per LWV-Richardson Bylaws: Article VII, Section 2. Annual Meeting.

An Annual Meeting shall be held between April 1 and May 15, the exact date to be determined by the Board of Directors. The Annual Meeting shall:

- a. Adopt a local program for the ensuing year;
- b. Elect Officers, Directors, and members of the Nominating Committee;
- c. Adopt an adequate budget; and
- d. Transact such business as may properly come before it.

This year, the League of Women Voters of Richardson's Annual Meeting will be held on Wednesday, May 13, 2015. The Annual Meeting is for members only. Watch your email for the time and place.

#### **Local Program**

The League of Women Voters is best known by the public for its Voter Service activities, such as producing *VOTERS GUIDEs* and candidate forums. However, another important part of the League's mission is to "influence public policy through education and advocacy." We take positions on issues and advocate for legislative change at the national, state, and local levels through our Program process.

On Wednesday, April 8, 2015, LWV-Richardson held its annual Local Program Planning Meeting (LPPM). It is at the LPPM that all local positions are reviewed and the LWV-R membership votes to recommend to the board to keep as is, to restudy, or to drop each position. The membership may propose topics for a new study, and may make suggestions for advocacy or education. See pages 4 and 5 for the recommendations of the April 8<sup>th</sup> LPPM.

The recommendations from the LPPM were reviewed by the board at its meeting on April 22, 2015. The board discussed each new topic for study and designated each as either "recommended" or "non-recommended."

All topics voted on by the members present at the Local Program Planning Meeting, whether recommended or non-recommended by the board, are then considered at the Annual Meeting.

#### Children's Health Insurance Program (CHIP)/Children's Medicaid

CHIP Children's Medicaid

There are a number of bills of interest to advocates of Child Health Care, some of which we can support. These bills are summarized in the latest Legislative Newsletter (Vol. 23, No. 6). Please refer to the Legislative Newsletter for details.

- ➤ HB 839 (Naishtat) has been referred to Public Health. It allows each child under 19 leaving a state facility to have presumptive eligibility to access and apply for a health care plan (CHIP or Medicaid) and identifies the benefits and services that child will need. Reported favorably as substituted. SUPPORT
- ➤ HB 3035 (Martinez, "Mando") relates to a study on the savings to the state achieved by the expansion of Medicaid managed care in regard to the provision of prescription drugs and other pharmacy benefits. House committee report sent to Calendars. SUPPORT
- ➤ HB 3036 (Martinez, "Mando") relates to a study on the savings to the state achieved by the expansion of Medicaid managed care in regard to the number of persons served and the scope of the services provided.

  Unfortunately, no bill to expand Medicaid has come up in Committee.



## Famous Firsts by American Women



**Diane Crump** (born 1948) is an American jockey and horse trainer.

On February 7, 1969, Crump became the first woman to ride in a professional race in the United States. Her participation in the event was so contested that she required a full police escort through the crowds at the <a href="Hialeah Park Race Track">Hialeah Park Race Track</a>. In a 2012 interview, Crump described what arriving at the race was like:

"The crowd was just swarming all over me. They were crazy, up in arms. The hecklers were yelling: 'Go back to the kitchen and cook dinner.' That was the mentality at the time. They thought I was going to be the downfall of the whole sport, which is such a medieval thought. I was like: 'Come on people, this is the 1960s!"


Crump ultimately finished 10th in the 12-horse race.

In 1970, she became the **first female jockey to ride in the <u>Kentucky</u> Derby**. Crump and her horse, Fathom, came in 15th in a 17-horse race. By the time she ended her racing career in 1985, she had ridden to 235 wins.

On February 1, 1989, Crump suffered a broken leg, ankle and ribs from a riding accident and was hospitalized for ten days.

#### **Expected Richardson Mayoral Vacancy**

#### **Background**

On April 2, 2015, Richardson Mayor Laura Maczka announced by way of a post on her Facebook page that she would decline the office of mayor following the May 9, 2015 election. The full text of her announcement read:

There have been questions about my role as mayor for the City of Richardson for the next term. After much prayer and conversations with my family, I have made the decision that I will not serve as mayor for the 2015-2017 term and intend to submit a declination of such office at the city council meeting at which the election canvass will be conducted. My focus will be on my family, my health and professional career. I'm proud of what we as a community have accomplished. I am confident that Richardson will continue to be a successful community to live, work, play and invest.

Because Ms. Maczka is the only candidate on the ballot for Place 7 (mayor), she will be elected to office.

#### City of Richardson Response

The City of Richardson posted a news item on its <u>website</u> outlining the process that will be followed to fill the vacancy created if Ms. Maczka declines the office to which she is elected. This process is dictated by provisions of the City Charter.

The city web page referenced in the previous paragraph descries the somewhat complicated process thoroughly. As a result of this process, the newly-elected council members will have chosen one of their members to serve as mayor for 2015-2017 (which will leave a council seat vacant) and another member to serve as mayor pro tem for 2015-2017. City Council will then determine when to act to fill the vacant council seat.

#### Richardson City Charter

<u>Article 3</u> of the Richardson City Charter governs the City Council.

Section 3.03 outlines the process for choosing the mayor pro tem.

Section 3.07 outlines the process to be followed in the event of vacancies on the council.

The full text of the City Charter is <u>here</u>.
